Section 2. The boundary of the County of Pierce is hereby established as the boundary for the Critical Water Supply Service Area.



In accordance with the Procedural Regulations for administering the Public Water System Coordination Act (WAC 248-56) the Pierce County Utility Coordinating Committee has formulated the attached recommendation and justification for the establishment of the critical water supply service area boundary for the County Coordinated Water System Plan.


The critical water supply service area boundary is the boundary which is established to define the area/areas within the County where problems exist relative to the provision of water service, and which will be addressed by the plan.

It is the concensus of the Committee that all of Pierce County be included in the plan and, consequently, the recommended boundary be the same as the County boundary.

WAC 248-56-600(4) requires that the County legislative authority conduct at least two public hearings on the boundary recommendation within six months from the date of submittal to the Council. If the Council takes no action to adopt the proposed or a modified boundary within the six month period, the proposed boundaries are automatically ratified.

Please transmit the attached letters of recommendation to the Council for their consideration. I would recommend that the first public hearing on this matter be scheduled as soon as possible.

Re: Recommendations for External Boundary - Public Water Systems
Coordination Act

Dear Mr. Gardner and Members of the Pierce County Council:

The Pierce County Water Utility Coordinating Committee (WUCC) has met in accordance with the provisions of the Public Water System Coordination Act and the associated actions taken by the Pierce County Council. The procedures of the law require that the WUCC meet and review the water supply needs of the area and recommend to you the desired study area referenced as the External Boundary of the study area.

The WUCC has met and discussed the needs of Pierce County water utilities and the need for improved water supply service. The WUCC has recommended that the entire County be declared a Critical Water Supply Service Area and that the provisions of the act be implemented throughout the entire County. This recommendation is based upon the following general conclusions:

- (1) There is a large number of water utilities providing water service under different design standards, conditions of service, and with a varying degree of planning to meet the future needs in both the urban and rural areas.
- (2) The anticipated result of the Coordinated Water System Plan will be beneficial to both the water utilities and County government in meeting the future needs of Pierce County. Therefore, the procedures and standards that will be developed by the water utilities should apply uniformly throughout the County and not just to a portion of the County.
- (3) The water resources of the County, and in particular the groundwater resources, that are currently utilized by a

major share of the water utilities are subject to potential contamination from existing developments in the County and potential future land uses. The recharge areas of ground-water aquifers are not restricted to the urbanizing area of the County but may be influenced by activities above the groundwater recharge area in more remote areas of the County. Therefore, the procedures and guidelines developed by the water utilities and County staff should apply uniformly throughout the County to recognize the importance of managing and protecting our groundwater resources.

- (4) Alternative sources of supply for future needs of the County include groundwater, the Green River, and possibly other surface supplies in the County, Therefore, planning for both retail service as well as source development should encompass the entire County.
- (5) One of the problems associated with water service in Pierce County is the large number of small water systems without an adequate revenue base and management system to expand to meet future needs in certain areas. It is important to prevent the proliferation of additional small inadequate systems and, therefore the entire water supply needs of Pierce County should be considered and appropriate guidelines and procedures developed to minimize adding to the small system problems.

During the two meetings of the Water Utility Coordinating Committee, the above issues were discussed and there were no objections to the recommendation to establish the County borders as the external boundary of the study area. Therefore, it is the recommendations of the Water Utility Coordinating Committee to initiate the two required public hearings by the County Council on the recommendation. We urge your immediate consideration of scheduling the two public hearings required and to add your support for establishing the County boundary as the external boundary for the study.

Responsibility During Development of Pierce

County Coordinated Water System Plan

Dear Mr. Rowe and Mr. James:

The Pierce County Water Utility Coordinating Committee is proceeding with the development of the Pierce County Coordinated Water System Plan (CWSP), in accordance with WAC 248-56.

It is anticipated that it will take from 1½ to 2 years to complete the CWSP. It is our understanding that the regulations restrict establishment of new water systems during the development of the CWSP except under certain conditions, and that subsequent to its adoption, procedures to establish new systems will be outlined in the completed plan.

To guide the WUCC, Pierce County, and the development community during the preparation of the CWSP, it is desirable to develop this letter of understanding with the Department of Social and Health Services. The procedure that will be followed in responding to inquiries on establishment of new water systems for both short plat and regular plat planning procedures is considered to be the following.

1. Existing Service Area Boundaries

On the date that the County Council adopts the External Boundary of the Critical Water Supply Service Area, the existing boundaries of water purveyors will be interpreted to be the following:

- a) municipal corporate boundaries
- b) water district boundary
- c) boundary review board designated boundaries
- d) existing distribution systems or a DSHS approved system map
- e) water service contracts based on item #2 below.

The boundary may include a combination of the above.

2. Identification of an Existing Public Water System

WAC-56-620 states, "No new public water system shall be approved within the Critical Water Supply Service Area subsequent to establishment of external boundaries unless specifically authorized by the Department."

For the purposes of this study, it is our understanding that if a preliminary plat or short plat application was <u>not</u> filed prior to the establishment of the External Boundary, that the associated water system will be considered new and will not be considered for approval except under the conditions outlined in this letter.

If the application for the preliminary plat or short plat was filed prior to the effective date and the processing of the final plat or short plat approval occurs prior to June 1, 1984, and the water system meets all existing Pierce County and DSHS requirements, the system will be considered an existing water system. Plats requiring a public water system must have a contract for service from a DSHS approved system or DSHS approved plans and specifications. Short plats must have a contract for service from a DSHS approved water system or a notice of availability of water acceptable to the Pierce County Health Department.

If the final plat or short plat approval occurs after June 1, 1984, the establishment of a new public water supply system must comply with number 3 below.

3. Establishment of New Public Water System

If new water service is required in an area not currently serviced by an existing water utility, as outlined in number l above, or the proposed new system does not meet the time requirements as outlined in number 2 above, an interim future service area boundary establishment will be considered, or a new system will be permitted under the following sequential steps. The identification of a probable future service area or identification of a new system service area will be based on criteria including, but not limited to: topography, readiness and ability to provide water, local franchise areas, future population, land use projections, sewer service areas, and the feasibility of expanding an existing system to serve the area.

a) If demand for water supply occurs within a purveyor's probable future service area, the following shall apply in the listed sequence:

- The existing purveyor shall provide service in a timely and reasonable manner consistent with state board of health regulations; or
- 2) A new public water system may be developed on a temporary basis. Before authorization, a legal agreement will be required which includes a schedule for the existing purveyor to assume management and/or connect the new public water system to the existing system.
- b) If a demand for water supply occurs outside any purveyor's probable future service area, or the probable future service area is uncertain, the following shall apply in the listed sequence:
 - 1) Those persons anticipating the need for water service shall contact existing nearby purveyors within the critical water supply service area to determine whether any will be interested in expanding their system to provide water service in a timely and reasonable manner consistent with state board of health regulations; or
 - 2) A new public water system may be developed on a temporary basis. Before authorization, a legal agreement with an adjacent system will be required which includes a schedule for the existing system to assume management and/or connect the new public water system to the existing system; or
 - A new public water system may be developed.

If a new water system is approved, the system shall have an approved water system plan pursuant to WAC 248-54-065. It shall anticipate and incorporate the provisions for complying with the anticipated Coordinated Water System Plan for Pierce County.

During the process in which the decision is being made about whether an existing purveyor should service the new development or a new water system should be developed, the criteria to be considered in assessing cost and level of service shall be at least equivalent to the level of service that would meet projected land use requirements or that is generally consistent with adjacent water utility design criteria, whichever is more stringent. DSHS design standards will be considered the minimum requirement.

The criteria to be used on evaluating cost allocations to new development will not be established until the CWSP proceeds to the near completion stage. The interim decisions, therefore, will of necessity be a negotiated compromise between the purveyor and developer, with the CWSP study team assisting if requested.

Concerning the resolution of service area designations where adjacent water utilities are seeking to provide future service to the same geographical area, it is understood that the adopted DSHS procedures will be followed in resolving such conflicts. The DSHS guidelines will not be utilized unless involved purveyors are unable to resolve the conflict by themselves with the assistance of the CWSP study team. It is the general intent of the study to not involve DSHS in a service area conflict resolution until near the completion of the CWSP.

In summary, we have reviewed these understandings with the Pierce County Water Utility Coordinating Committee, and are submitting these to your office for review. If you concur with this understanding, we will use this as a guideline during the development period of the CWSP. Upon final adoption of the CWSP, this understanding will be replaced by the procedures adopted within the plan and state law. May we have your written concurrence of this understanding.
