Applicant / Owner Information: Located on page 2 – signature of owner is required if not the applicant. **Description of Request/Business:** Provide a detailed description of the nature of your request (see page 3 of form).

Site Plan: Site plan must be drawn to scale (not less than 1"=100'), show all property corners, existing and proposed structures, adjacent roads, all storage tank locations, all easements, well locations, and north arrow.

History of Uses of Site: Provide a detailed chronological list and description of uses that have occurred on the property. Also include information such as: number of employees, square footage of structures used (see page 3 of form)

Animal Waste Disposal Information Sheet: For Health Department review of kennel or cattery.

Assessor Treasurer Segregation Information: Provide copies of segregation information which can be obtained from the Assessor / Treasurer's Office.
